Business Situation

Aeon Nexus wanted creation of separate folders for their business subjects (CAU, PI, Common, Investigation, Victim Witness, and Contact) in different document libraries within SharePoint so that any file associated with these subjects will go in respective folders. Generally, out-of-the-box SharePoint integration with CRM creates all folders in a single document library.

Solution

MTC understood the challenge and immediately proposed a feasible solution using which Aeon Nexus could achieve automatic provisioning of folders in SharePoint document library configured for respective business subjects.

- a) When a Case (Incident Entity) is created with Assigned Team as CAU
 - Folder will be provisioned programmatically (using SharePoint REST API's) in document library URL configured for CAU in the SharePoint Config Entity

- SharePoint Document Location Entity will be updated with the provisioned folder
 - The folder url would be <u>https://<<CAU Document Library>></u>/<<pre>prosecutoroffice>>/CASETITLE CaseGUID
 - > This would be async workflow registered with partial trust (Sandbox)
- b) When a Case (Incident Entity) is created with Assigned Team as PI
 - Folder will be provisioned programmatically (using SharePoint REST API's) in document library URL configured for PI in the SharePoint Config Entity
 - SharePoint Document Location Entity will be updated with the provisioned folder
 - The folder url would be <u>https://<<PI Document Library>></u> /<<pre>consecutoroffice>>/CASETITLE_CaseGUID
 - This would be async workflow registered with partial trust (Sandbox)
- c) When a Case (Incident Entity) is created any other Assigned Team
 - Folder will be provisioned programmatically (using SharePoint REST API's) in document library url configured for Common in the SharePoint Config Entity
 - SharePoint Document Location Entity will be updated with the provisioned folder
 - The folder url would be <u>https://<<Common Document Library>></u> /<<pre>prosecutoroffice>>/CASETITLE CaseGUID
 - > This would be async workflow registered with partial trust (Sandbox)
- d) When an Investigation (anc_Investigation Entity) is created
 - Folder will be provisioned programmatically (using SharePoint REST API's) in document library url configured for Investigation in the SharePoint Config Entity
 - SharePoint Document Location Entity will be updated with the provisioned folder
 - The folder url would be <u>https://<<Investigation Document Library>>/<<</u> anc_office>>/CASETITLE_CaseGUID
 - > This would be async workflow
- e) When a Victim Witness record (anc_victimwitness Entity) is created
 - Folder will be provisioned programmatically (using SharePoint REST API's) in document library url configured for Victim Witness in the SharePoint Config Entity
 - SharePoint Document Location Entity will be updated with the provisioned folder
 - The folder url would be <u>https://<<Victim Document Library>> /<<</u> anc_office>>/CASETITLE_CaseGUID
 - This would be async workflow registered with partial trust (Sandbox)
- f) Contact record Async On-Demand Workflow
 - Folder will be provisioned programmatically (using SharePoint REST API's) in document library url configured for Contact in the SharePoint Config Entity
